- Town Manager Killman has requested an Executive Session to discuss Real Estate and his Personnel Evaluation/Review.

Town Manager Report

- The seed for the greens at Butterfield Golf Course and Coyote Wash Golf Course has worked out well. The fairway seed is a different variety than has been previously used. Mixed reviews.
- Coyote Wash Golf Course has been rated the #9 Most Improved Golf Course in US by Golfer's Choice.
- Planning and Zoning Code Update is going to be worked on by the attorney. It requires some significant rewrites. The rewrites will need internal review as well as discussion.
- ADEQ Consent Order the Approval to Construct (ATC) for the Emergency Well has been approved. A blend of 80/20 (canal water/well water) has been approved.
- Links at Coyote Wash Utilities (Jason Williamson) has exceeded the capacity and must be upgraded. Looking towards the future of development and the potential need for expansion outside of the existing footprint – TM Killman reached out (on behalf of Mr. Williamson) to Wellton-Mohawk regarding a 5-acre site for future use.
- More than 1,500 bills are currently in the State Legislature. The summary is 60 pages long. Several of them will affect the Town of Wellton in the future.
- A few Staff members will receive their 2nd dose of the COVID-19 vaccine on February 4, 2021.
- Five new businesses applied for business licenses in January 2021.
- Butterfield Golf Course is down \$16,000, Coyote Wash Golf Course is down \$68,000, and the Den is down \$13,000. The losses are a result of reduced revenues.
- Staff to meet with STIFEL next week regarding the potential of bonds for the PSPRS Liability.
- TM Killman recognized Chief Rodriguez for the smooth transition in leadership and Finance Director Hernandez for the good reviews from the CPAs and auditors.
