- Contributions and transfers equal \$247,000.
- Police Department Town to work in conjunction with Arizona @ Work to sponsor a new police office and increase staff.
- Fire Department
 - Potential new truck
 - o Insulation installation in the Fire Station. Company required one-half payment upfront to begin work.
 - Open Hose 2nd week in June.
- Pool budget up an additional \$40,000 to aid in the repairs.
- \$2.5 million for FY 21-22
- CFD 2003-1: scheduled repairs of the streetlights in Coyote Wash, Units 1 & 2 (an additional \$35,000).
- Tentative Budget approval on June 1, 2021 Meeting.
- Fees to be approved at same meeting. Fees will be effective July 1, 2021.
- Final Budget to be adopted on June 15, 2021.

5. Discussion and information regarding the ND & Katie Kline Pool

Discussion led by Town Manager Killman.

- Still waiting on contractors for quotes for repairs.
- Councilmember Blitz had an outside contractor quote him for some of the repairs (\$123,000). Recommendation to do repairs during the winter.
- Potentially will have quotes by the June 1, 2021 meeting.

6. Discussion and information regarding The Links at Coyote Wash Utilities Wastewater Treatment Plant.

Discussion led by Town Manager Killman.

- TM Killman and Council met with the Jason Williamson (owner of the Links at Coyote Wash Utilities Wastewater Treatment Plant).
- Plan is to go to full build out (235,000-gallon capacity per day).
- They are working with ADEQ on the permitting process for the design.

- Plans are to meet with the community to detail the process.
- Responsibilities:
 - Sewer Treatment Plant Williamson
 - Discharge Permit to the Pond Williamson
 - Discharge Permit from the Pond to the Golf Course Town of Wellton

- Tentative Budget to be on agenda for the June 1, 2021 Regular Meeting.
- Potential Commercial Trash Truck used 2020 Mack for \$251,000 was a trade in.

Town Manager Report

- Open House at Fire Department 2nd week in June.
- Insulation to be installed at the Fire Station in July as mentioned in Budget Review.
- The Approval of Construction (AOC) for the Emergency Well is currently in process by the Engineer. As soon as it is complete, it will be submitted to ADEQ for approval.
- New chlorinator has been installed. This was a \$26,000 investment. The goal is for this new installation to help with the TTHm issue.
- VSS has completed the slurry work in Town. Staff is very pleased with the results.
- There are plans for a county-wide ½¢ Transportation Tax for road repairs. The committee is still in the planning process.
- The railroad crossing on William Street will be closed for crossing replacement on June 6 and June 7.
- Kid's Club has been tentatively scheduled for July 6 July 22 (M-Th) from 8:00AM 11:30AM.
- League Finance call discussed the provisions of the American Relief Grant. May hold Cities/Towns harmless. Projects must be shovel ready to move forward.
