- Where is the money coming from? Current Budget and the Relief Act Monies.

• Will there be additional repair needed (additional costs)? The tank will be brought up to meet current ADEQ regulations.

b. the Superior Tank Solutions proposal for the upgrade of Tank 2 at the Water Plant; and

c. the Big Wave Water Technologies proposal for the install of The Hurricane-100 Air Ventilation and TTHm Mitigation System in Tank 2 at the Water Plant.

- 5. Discussion and possible direction regarding the pursuit of a City Sales Tax Increase. Discussion led by Town Manager Killman regarding the potential pursuit of a City Sales Tax increase. Examples:
 - Sales Tax comparison of surrounding areas and similarly sized entities.

- Discussion regarding reduced revenues compared to last year's July/August.
- The Census currently has Wellton at 2375 population. The State estimates 3350 (based on income tax returns). The State Shared Revenues are paid out according to the Census numbers. This would be an estimated \$217,000 reduction in Shared Revenues. The question at the state level is Can the State numbers be used to allocate the funds as opposed to the Census numbers?
- A Property Tax question would be a Special Election in 2023. While the City Sales Tax question could be handled in-house with ADOR assistance to implement the change. This would be a 6-month turnaround.
- Comment form Council Would like to look at Budget and investigate the items that have consistently lost money before going to any increases.
- Public Hearing to openly discuss both the City Sales Tax increase and Property Tax question.
- 6. Discussion and possible action to proclaim October as Domestic Violence Awareness Month.
