### Town Manager's Report

- Introduction of Grants Consultant, Nancy Ngai:
  - Worked for Yuma County for over 28 years as Grants Manager
    Obtained/Administered over \$200 million dollars in grant funds.
    - Managing Community Development Block Grant Program
    - First to designate Colonias in Arizona
    - Created Owner Occupied Housing Rehabilitation Program
    - Facilitated and established more than a dozen Improvement Districts for improvement projects
    - Created grant policies and handbooks
    - Created grant training program for County Departments
    - Some of her Projects she worked are:
      - Water/Sewer Projects Speese Addition, Donovan Estates, Gadsden, Dateland, Avenue B/C, 208 Plan
      - Economic Development Projects Yuma Port Authority, Underhill Development, Investment in Manufacturing Community Partnership,
      - Energy DOE Block Grant for energy efficiency
      - Housing Over \$1 million annually in housing repairs, Created policies and administered over \$11 million in Emergency Rent Assistance
      - Broadband Assisted and facilitated funding and project implementation for the Middle Mile Project
      - Community Parks Development & Renovation Gadsden Park, Tacna Park, Esperanza Park, Foothills Park

- Staff attended the virtual meeting with the states Rural Water Infrastructure Committee on March 12, 2024, to discuss the need for funding for the Clarifier Project at Wellton Water Plant. Options for funding were expressed by some of the attendees. Staff have followed up on those leads. The representatives of Partners that were in attendance were:

  - o Arizona Department of Housing
  - North American Development Bank
  - Rural Community Assistance Corp

- Chief Rodriguez received a grant in the amount of \$380,000. It will be utilized to purchase and outfit 4 Chevrolet Tahoe's.
- Federal Program HOME update:
  - The environmental was not submitted to the state for approval as I was informed. The homeowner is patiently waiting. We are working with the state and the county to serve this homeowner.
- Department of Justice Grant update:
  - The Chief wasn't able to access DOJ portal to complete grant process as I was informed, staff working with DOJ to determine status.
- On April 5, 2024, Nancy Ngai will submit a grant in the amount of \$ 1.8 million for installation of the Clarifier to Senators Kelly office through the Discretionary spending program.
- The installation of the Flock Safety Cameras has begun. Chief Rodriguez reported installation of 8 cameras will take place in the following locations:
  - William Street and Commerce Way
  - William Street and Los Angeles Avenue
  - Water Plant (on Dome Street)
  - Town Hall and Police Department Area
  - o Coyote Wash Pro Shop
  - Entrance of Coyote Wash 3
  - o Butterfield Pro Shop
  - o Butterfield Park
- We have posted the advertisement for the part-time Grants Director position.
- Council Candidate update:
  - o 7 Nomination packets were pulled, and 5 packets were turned in.
- An incident involving an employee at Coyote Den resulted in the employee being released from employment. Employee was found intoxicated behind the wheel of his car in the Den's parking lot, it was discovered he had a warrant. I have asked the DPW Director to provide me with a report on what occurred. I have also asked the Chief to speak with employees that worked with the employees that day. In addition, I have requested that HR work with the Chief when on boarding new hires.
- The Easter Egg Hunt at Butterfield Park on Saturday, March 23, 2024, went very well. It is estimated that 300 people were in attendance.
- Wellton Municipal Airfield Project being led by new DPW Director with Joe Grants departure. We will keep you updated as this project progresses.
- Coyote Wash, Community Park Park Consultant did not deliver rendering as promised staff will contact another consultant to complete this work.
- DPW Director is working on obtaining quotes for retrofitting the Community Center to hold Town Council meetings.
